- Open to UK residents aged **16 or over**.
- Proof of age and identity may be required.
- Employees or contractors directly involved in running the competition may be excluded.

How to Enter

Eligible entrants will be **automatically entered** when they:

1. **Sign up** to the Move Our Way Challenge, and
2. **Raise £50 or more** by 12th February 2026 via their Enthuse fundraising page.

Only one entry per eligible participant.

Participating Venues

- **Chelsea Sports Centre** – for the **30-Day Membership** only
- **Kensington Leisure Centre** – for the **Spa usage prize** only

The spa prize is valid exclusively at Kensington Leisure Centre.

Each eligible entrant will have the chance to win one of 4 prizes, **either**:
